PUBLIC RECEPTION NOTICE

I now inform all, that after the blatant disrespect of calling police on me, just when visited her office, after she was made aware that I would present myself that week (sometime around early September 2025), and the way that I was treated with disregard by your department, although, I was there to offer the honored nomination to you, the police officer who you sent, had threatened a restraining order against me, a major hypocrisy of yours, in light of everything your office was made privy of. It is decided, then, that your nomination as part of our international foundation should be rescinded, from Royal Keep and Dr. Nana Lawson Bush as Grand Politico Minister nominee.

Crucially, the reason for this sentiment is principle. That is, you stand on an 'abolish the police' agenda but have used them against a Black man, who meant you no harm. However, to call for abolishment of the police department, it is hypocrisy to then have them called and to have had a Black man under surveillance of the LAPD. Your kind of crowd has been nothing but an impediment to African Americans and counterintuitive to any of my liberation efforts which you have cost peoples' lives, Dr. Abdullah. The irony and bigger slap to his face, that I was suspended twice from CSULA in graduate school for defending the lives of Black people, and you have allowed Blacks to perish. You are also suspected of involvement, in the surveillance conspiracy against me, orchestrated by Romeo Miller, Shad Moss, and Dwayne Carter, which is linked to fraternal societies, private security and private investigator firms, satellites, drones, scanners, confidential informants and the like, among other things.

Melina Abdullah, you don't deal with real issues, you make advantage of media sensations and profit off the death of my people. Your company has an agenda that allows you to profit only when a Black person is killed by police, and so, bad business indeed. The worst is to know, that you have a very minute reach in the Black community, anyway, but an extensive reach into foreign bodies, with your campus and classes composition. You have neglected your duty to the African American community and exposed them to foreign invasion and exposed their culture to foreigners and you don't even reach them with your teaching, because there are no Black people at Cal State Los Angeles, as it is LSI. It makes it worse that Dr. Melina Abdullah is operating a scandalous scheme of fraud against the Black community, not even reachable; that she has a fake physical address that I have visited. She has fake phone numbers which I have called and a fake website that I have contacted for help with court prejudice and have yet to receive a response from Black Lives Matter Grassroots.

Nana Bush, your mentorship may be well intended, but failed anyway. You don't control any kind of economy for your people so how you going to tell them how to live? What you do do is condition their conformity to White supremacy and or insanity. You are at a dead end. You are out of your place.

Lastly, it is a pitiful shame that you put this kind of shame onto the Pan African culture, however, not in lonesome company; as the Black Panthers had a similar experience, with some of your stock. I have been organizing my whole life and when it comes to Black people, we have work to do. You are a major red flag, with potential for spying on the Black community, undercover, as a secret agent, and this makes sense, because the fact you are not Black but a White woman, absents all other things. That is your father is a full blooded White Jewish man, seen above. and it is noted in the national records of the United Nations Of African America. Pending a hearing, you are still eligible for citizenship, but may not hold any political post.

However, something else, entirely, to know about cointel pro and the potential effects, you sit up and try to sink my ship; even though the first thing I did when I arrived at CSULA, as a student, was meet with Melina Abdullah, in the Pan African Department and made notice of my intentions. I never took a single Pan African class but had relationships with the entire faculty and staff, my time there, in anthropological studies.
