However, clearly, a complete catcher term, id est, whether African American, Black American, Black Native American, Black Moorish, Hebrew Israelite, Black Muslim, Black Protestant or any other of the like, you are still eligible, as a potential full-blooded or part-blooded member-citizen of the United Nations Of African America. Bring your religions; bring your skills; bring your aspirations. Uncle Skeeter says, he wants you, courtesy of the Grand-Supreme Master Negus Anthony R. Ivey, Jr. and an United Nations Of African America (UNAA).

## DO YOU QUALIFY AS A FULL-BLOODED AFRICAN AMERICAN, FOR UNAA NATIONAL REGISTRATION PURPOSES?

- 1. African Americans shall be considered descendants of and represent the Black people of all our African American Nations, the African Aboriginals, Freedmen, Refugees, and all our lineages around the planet earth and the whole universe that are now or that ever were before Black Slaves, Negroes or Freedmen of the North, Central, South Americas and the Caribbean Islands, effective of those chattel laws imposed onto our kidnapped personas; but not whom be of those non-citizen immigrants and residents of Black or African descent that are of our contemporary brethren, although, in the United States; and we are national affiliates, but not those counted amongst our brethren within those Five Civilized Tribes of Native America; still included, here, and to be accounted amongst us, they are also, those other Freedmen who are too Native American Freedmen in ethnicity, but they are unaccounted amongst our Freedmen brethren of the Five Civilized Tribes, et. al., to consider the eligibility of an affiliated Member-Citizen.
- a. African Americans that satisfy Section One of this Article must also have been registered Black or African American or the like, in North, Central, South America or the Caribbean Islands, in the year Two Thousand Twenty, or a lineal descendent of the same, based on official business to government documentation, personal tax filing status, any kind of United States (I)Nine documentation sets, or other acceptable documents of the like that may be available, such shall suffice proof of race and ethnicity status; and an affiliate must have one parent, up to a Grandparent, at least, that was also registered in the United States Of America as African American between the years of Two Thousand Ten and Sixteen Hundred Twenty.
  - i. The designation of 'other' or 'mixed' or any other vague term of the like, alone, they do not suffice, but for documentation that declares explicit, in expression that one is 'Black' or 'African American'.







#### A MEMO TO THE BROTHERS AND SISTERS

#### **ATTN: AFRICAN AMERICA!**

Herein, forthwith, on this day ofourgods, in the year two thousand twenty-four, we issue a plea of unity, to all the nations, traditions and peoples of AfricanAmerica, whereby, there is presented, a plan for reparations and a design for a governmental amalgamation ofourvested interests. Our mean is toward the seizure of reparations, through resources, provisioned by particular agenciesofthe United States government and in legislation. In commencement, to this critical engagement of a national assembly,conventional to reparative addresses, our hands are sanitized, with the oil of Nat Turner; and in regard of the vital imperativesthat are necessary actions, to ours, today, although, the spirit may accommodate a vibrancy, in eternal sway, but forever,is not the way of the flesh, anyway; and for the repair of our people, we will have no desires of contradiction, unconditionally, about any of our days, now.

This reparative mission does not aim to resolve into a simple monetary compensation, in the form of some kind of pay check, competently; and such would represent a discounted valuation of life, projected upon the perpetuated generative centuries of captured and tortured souls of African American people. Rather concluded necessary—and our ambition is based on assessments of relevant temporal conditions, given critical attention about them—that of this problematic continuum, reflected in the harsh imbalances of resourceful access to economic opportunity, ethnic-volition and national prosperity, between our people and those foreign, there is the development of an independent African America; and such considered solvent, therefore, by which insight, id est., we call upon our churches, mosques, temples, schools, shops, studios, rooms,

#### TO DEFINE REPARATIONS

A caveat must be asserted, about our mission, for clarity, somethings that regard African American reparations should have no confusion; and let there be no misconstruction about reparative remedies, to the same suite: they are not stimulus checks; not personal monetary payments that would be valued less-than what the average financial accumulation of one lifetime is anyway—but to sum-up two hundred fifty years of slavery, thus more-than twenty generations and ten million lifetimes, inter alia, and several centuries of slave-codes, black-codes and Jim Crowe codes, the perpetual racial economic gap, and continuum of violence etcetera—and of which such payments would be issued to arbitrary households, based on arbitrary familial heritage relations, with faulty results; although, unless there would be recipients of generational payments that should span centuries, in the hundreds of thousands, if not millions of dollars, per issuance, maybe paychecks would work the job; but not a mere amount worth a down payment on the house of one familial generation or a television, laptop or mattress for the bedroom which is what some have proposed and offered of recent times, an insult to our ancestors, our contemporary selves and the lineal generations of our future existences. Another important feature to the resolve of paycheck, a theoretical reality check, that the United States need but to raise economic duties of national manufactured and marketed products and services, and those heightened costs will devalue the gains of those proposed reparative paychecks; not only do such compensatory means come to an end, and would not equate to any kind of relevant redistribution of control to political, material or traditional resources of which are the powers that determine job availability and employment acquisition, as well, institutional upward mobility and an empowerment of the people to determine self,

#### **ALIENS OF THE UNITED STATES**

There is an unfortunate misconception of essentiality, about the stubborn attitude carried throughout the minds of many, which has naturalized into traditional common sense, that African Americans are native to the United States, and for sake of integral ethnic identity and propriety of reparative efforts, this perspective wants attention. Such is not to contend-of-way that suggests our contemporary people—of whom have been born In the United States or any other way constitutionalized as a citizen—are foreign beings; although, to opine that the African American race is one of a foreign people. For on one hand, truly, African Americans originated of form, as a people, enslaved through the colonies and onto the antebellum days of the United States. Literally, there were major meshes of cultures, from the continent of Africa, within the enslaved people, for over two hundred and fifty years, in the Americas. Furthermore, in another grip of hands, when the recognition of racial citizenry is considered, African Americans were not immigrated into this nation, until around one hundred years after the United States had founded a constitution, when Abraham Lincoln proclaimed the emancipation of our people, although by force, refugees of no land or nation.

Inclusively, if factored, even, in the time, the population of Free Blacks does not reduce the effect of the enslaved population, because the number of Free Blacks was so nominal that it bore no amount of significance on the population of enslaved people, per historic record, pre-Eighteen Sixty-Five; but also, Free Blacks consisted of those collected from the three fifths clause, and so, many were White people and others, not of actual African ancestry; and, as well, not to mention that many Free Blacks of the time were sent to Liberia, especially, those of African descent.

#### TITLE ONE:

### WE ARE NATIONAL AFFILIATES SECTION

1.

- c. Initiation of membership shall entail a duly sworn commitment of loyalty, to the United Nations Of African America, as follows:
- i. WE, THE PEOPLE OF THE UNITED NATIONS OF AFRICAN AMERICA, DO PLEDGE THIS OATH OF LOYALTY:
- 1. I am always accountable, to the republic of my people, the United Nations Of African America, trustworthy to myself, and dedicated to our collective triumph; and so that I can better serve the interests of my national community, I strive to overcome my individual adversities, every day, always, with solemn character; and I pledge this oath, in the name of my creator, almighty; and may our kind be beautiful and glorious, with bountiful victories that flourish into great seas.
